INCJ completes sale of shares in UniCarriers Holdings Corporation

Tokyo, March 31, 2016 – Innovation Network Corporation of Japan ("INCJ") announced today that it has completed the sale of its shares in UniCarriers Holdings Corporation. This follows its announcement on July 31 2015 that it would sell its entire stake to Mitsubishi Heavy Industries, Ltd. and Mitsubishi Nichiyu Forklift Co., Ltd*.

*On March 1 2016, Mitsubishi Heavy Industries Ltd. established Mitsubishi Heavy Industries Forklift and Engine Turbocharger Holdings, Ltd. to oversee its material handling equipment, engines, and turbochargers businesses. Through the transaction announced today, Mitsubishi Heavy Industries Forklift and Engine Turbocharger Holdings has acquired shares in UniCarriers Holdings Corporation on behalf of Mitsubishi Heavy Industries Ltd.
